President's Message

As this is my last Official Word article as CCAC President, I'd like to provide "Team Clerk" with a final recap on the 2010-2011 Goals and

a status report on the happenings at the FPPC, League, and IIMC.

2010-2011 Goals

Approximately one year ago, the Executive Board identified the following three goals for the 2010-2011 year: (1) engage the membership in a sustainable manner to encourage maximum participation at all levels of the Association, (2) provide professionally relevant education responsive to the membership while facilitating CMC/MMC certification and/or higher education, and (3) promote the understanding of the City Clerk's role as an executive municipal officer. I am happy to report on the successful achievement of these goals through the completion of specific tasks including, but not limited to, the following:

- Conducting a membership survey to ascertain the professional and educational needs of the membership at large. Results were made available at the annual conference, through listserv and on the website.
- Implementing the usage of standardized CMC and MMC press releases to be sent to municipalities and the local press

upon receipt of designations.

- Adopting policies for actively engaging the membership through social media and membership interest cards.
- Contributing professional expertise through specific participation with the FPPC Task Force and League Governance Committee.

The above-referenced list is a small sampling of the types of tasks that were completed this past year thanks to the dedication and commitment of the volunteer CCAC Board.

FPPC – Task Force

We stepped up the FPPC involvement this year by actively working with the FPPC Task Force created by former Chairman Dan Schnur to provide recommendations regarding overhauling the Political Reform Act. Our Legislative Director Dawn Abrahamson and I attended a variety of meetings, reviewed proposed changes and provided commentary regarding the real world application of the regulations at the local level. We are continuing that involvement with the new FPPC Chair Ann Ravel. Ms. Ravel has a local government background and is encouraging participation from the clerks. She has sought our input on a variety of documents including the newly drafted gift regulations. Dawn and I will continue to participate with the FPPC on behalf of CCAC and report back to the membership through the listserv and Official Word.

League – Governance and Administrative Services Committees

It has been quite a year with the League. I'll

leave the details of the League happenings to our Legislative Director but will briefly touch on the Governance and Administrative Services Committees. In response to the Bell incident, over 30 bills were introduced that directly related to local government. The League pulled together a small group of city managers, city attorneys, city clerks, and finance directors to review and provide comments on these bills. We saw everything from minimum educational guidelines for clerks and managers being set by state officials to the proposed disincorporation of the City of Vernon. It was a chaotic time period to say the least but thankfully the worst of the bills did not survive. The legislative cycle officially ends on September 9 after which we will receive a final summary that we will pass along to the membership.

IIMC – Ad Hoc Legislative Committee

One of the highlights of the year for me personally was to see our very own Colleen Nicol sworn in as IIMC President in Nashville, Tennessee. It was such an honor to represent CCAC at that conference. The IIMC Board created an Ad Hoc Legislative Committee to monitor and review federal legislation pertinent to the municipal clerk profession, identify trends in state and international legislation affecting the profession, and when appropriate provide relevant written reports regarding the same. The 11-member committee representing all regions in IIMC met via conference call for the first time on August 17. The committee is in the early stages of developing its scope of work, policy statement and topic

areas for monitoring purposes. As Region IX representative and chair of the committee, I will keep you apprised of its future happenings through listserv and the Official Word.

Representing "Team Clerk" this year was challenging by way of time constraints yet rewarding by way of the people I met and the work we completed. I would like thank everyone without whom this last year would not have been possible – including my son DJ for his patience while I was traveling, my parents for covering on the home front, and my Assistant City Clerk Jennifer Robison and Administrative Clerk Maria Becerra for covering on the office front. And a special thank you to the membership at large for allowing me this opportunity to serve you and our organization – it will be a year I will never forget.

Many years ago when I first became a City Clerk, then retiring City Clerk Nancy Dillon asked me to get involved by taking her place on the League Administrative Services Policy Committee. I remember her words clearly. Nancy told me once you get involved in this profession you will always be involved and you will never regret the time you spend even if it is voluntary. She was absolutely right!

So while I am signing off for the last time as CCAC President, I'll remain involved with the profession for years to come and encourage everyone to do the same because "Together Everyone Achieves Much."

2011-12 Northern California City Clerks Association \$1,000 Grant Program

Applications Accepted in October and November

Summary: The Northern California City Clerks Association (NCCCA) Grant Program was established to assist and encourage NCCCA members to pursue projects that will provide innovative solutions to municipal operations in the City Clerk's Office, enhance citizen participation and promote the City Clerk profession. Grant monies may be expended for supplies, materials, staffing, advertising, training, software, hardware, etc. needed to complete the project.

Projects: The NCCCA will award (1) \$1000 grant for a proposed project in one or more of the following categories:

- (a) Elections
- (b) Records Management
- (c) Public Relations

- (d) Council or Legislative Procedures
- (e) Development of the City Clerk's profession
- (f) Minute or agenda preparation
- (g) Special Project
- (h) Technology

Eligibility: Any paid member of NCCCA in good standing of at least one year is eligible for the NCCCA Grant Program, excluding any city with a representative on the NCCCA Executive Board during his/her term of office.

Applications must be completed on the approved form and submitted to the Division Chair, the grant announcement will be made at the January 20, 2012 meeting in Milpitas.

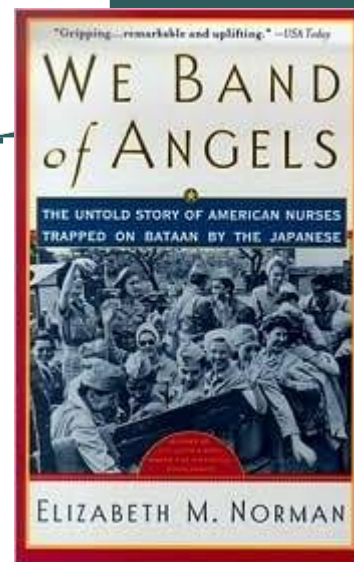

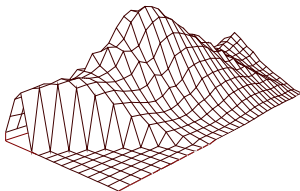
