In addition, participants will be better able to identify the contexts which cause conflict and maintain clarity during those moments.

Traveling the I-405/5 Southbound - Exit I-5 Freeway at Crown Valley Parkway, make a right on Crown Valley Parkway, drive approximately 4.4 miles to Clubhouse Drive, make a left on Clubhouse Drive and drive 0.2 miles. El Niguel Country Club is on the right. If you dead-end on Crown Valley Parkway at Pacific Coast Highway, you have passed Clubhouse Drive and gone too far.

Traveling the I-5 Northbound - Exit I-5 Freeway at Crown Valley Parkway, make a left on Crown Valley Parkway, drive approximately 4.4 miles to Clubhouse Drive, make a left on Clubhouse Drive and drive 0.2 miles. El Niguel Country Club is on the right. If you dead-end on Crown Valley Parkway at Pacific Coast Highway, you have passed Clubhouse Drive and gone too far.
