

long tuition, options. One or three day IIMC approved leadership training in locations that are close by and at significantly reduced costs is a win-win for CEPO and CCAC. These are all Institute trainings! GO CEPO!!!!!

CCAC Board Report

The June Board meeting was a two-day meeting as your Board worked diligently to pass a balanced budget. We were able to balance our budget by an incremental increase in our dues of \$10. It is important to note that CCAC has not raised its membership fees in decades, and during that time the organization has experienced escalating costs (example: insurance costs, travel), we have added additional services (example: web hosting, and additional professional services such as legal advice and accounting/auditing services), we have added additional scholarship awards, at the same time as we have lost interest income due to diminished interest rate returns due to the economic downturn. Recently, IIMC also approved an across the board \$10 increase to its membership fees.

A fee increase is not something that the Board takes lightly, as evidenced by the long length of time we have held membership fees stable. The Board felt there was sufficient justification to take this step this year, as all expenses are very tightly budgeted and there were no other places to cut.

The Board also approved a bylaw amendment for the 2014 election. I mentioned in my June article that we were examining the possible need for such an action. The proposed amendment is to address changes

need from the adoption of the financial policies, some comprehensive word changes and modifying our objections to more closely reflect the Association. In future editions of the Official Word each proposal will be fleshed out for the membership before the official notice next June.

Statewide CCAC Board Election

Ballots will be mailed for our Statewide CCAC Board election on July 9th. Make sure to mark your ballot and mail it in; as we want to demonstrate as election officials we are not complacent with our elections as the voters in our cities, counties, and nation have become. Get Out The Vote!!!!!

Legislative Director's Update

The Administrative Services Committee met on June 14, 2013 in Sacramento. Prior to the actual meeting, all members of the various policy committees received a special briefing on the Governor's pending budget.

Enterprise Zones

The budget trailer bill includes details of the Governor's proposal to eliminate the Enterprise Zone program and use the \$750 million on the following three programs: (1) exemption from State share of sales tax for purchase of manufacturing equipment, (2) new and more restrictive hiring tax credit program focusing on the poorest 25% census tracts, and (3) empowering the Governor's office of Business and Economic Development with broader authority to negotiate tax benefit packages with employers. While some of the new programs appear to be valuable, the League remains concerned with the elimination of an existing program that works for cities in order to fund a new program that is unknown at best. The Governor will need a 2/3 vote of the Legislature to eliminate the current Enterprise Zone program. The committees also received an update on the status of pending infrastructure bills, Proposition 39/Cap & Trade and the recommendations of the League Immigration Reform Task Force.

Public Records Act

There was an interesting provision in the proposed 2013-2014 budget pertaining to the Public Records Act (PRA). It recommended that the Legislature recast the PRA mandate provisions as optional best practices—eliminating the State's responsibility to reimburse local governments for these activities. Each year a local government would be required to either: (1) comply with the best practices or (2) announce at its first regularly scheduled public meeting that the local government will not meet the best practices. After facing intense scrutiny from the media outlets and public watchdog

groups, the Governor's office, as well as leaders in the Assembly and Senate, pledged their support for a "fix it" bill which restores the Public Records Act (PRA) mandate. In addition, several legislative members and the Governor indicated support for a Constitutional amendment further strengthening the PRA. The net effect of the politics surrounding this issue over the last few weeks for our profession was zero. We'll continue to adhere to requirements of the PRA as we have done in the past.

AB 1090

In the Administrative Services Policy Committee meeting, the Committee provided general direction to support AB 1090 (Fong). AB 1090 would make a person who violates the prohibition against being financially interested in a contract subject to administrative and civil fines and authorize the Fair Political Practices Commission (FPPC) to enforce these violations upon written authorization from the district attorney of the county. Previously the enforcement fell under the Attorney General's jurisdiction. While the Committee appreciated the ability to obtain relevant advice on this topic from the FPPC, they were cautious about the timing of FPPC responses based on previous experience with the agency. The Committees' concerns will be included in the letter of support. The FPPC City Attorney's group expressed similar benefits and concerns with the bill on a related conference call a few weeks ago.

Immigration Reform Principles

The Committee also unanimously approved the recommended immigration reform principles of the League's Immigration Task Force as presented. The four other policy committees to which the recommendations were presented also approved the same. The recommendations will now go back to the Task Force and Board for final approval. The

approved immigration reform principles, patterned off of the National League of California Cities' resolution, are as follows:

- 1. <u>Prompt Action Needed</u>. Congress should move quickly to enact comprehensive reform of the current immigration laws with support of the Administration to implement the immigration laws effectively.
- 2. <u>Consistent Federal Enforcement Required</u>. The federal government should enforce its current immigration laws consistently and vigorously to eliminate illegal entry at the borders, visa overstays, working without proper documentation, and employing undocumented workers.
- 3. <u>Increased Enforcement of Visa Laws Required</u>. The federal government must increase enforcement of visa overstays through the full implementation and staffing of the US-VISIT and SEVIS programs.
- 4. <u>Do Not Mandate Local Enforcement of Federal Immigration Laws</u>. Local personnel, such as police officers, fire inspectors, educators, health personnel and social service personnel, should not be conscripted into federal service because the federal government has not adequately funded and staffed its immigration enforcement agencies; and the federal government must not transfer the responsibility of enforcing U.S. immigration laws to local personnel by making undocumented status in the U.S. a criminal offense.

- 5. Increase Worksite Enforcement; Modernize Verification System. The federal government must strengthen its worksite enforcement capacity and dramatically increase enforcement efforts at places of employment, as well as providing employers with a universal, reliable, effective, secure, non-discriminatory, and non-counterfeitable employee verification system, using the most up-to-date technology that will minimize fraud.
- 6. Provide Efficient Process for Securing Visas and Legal Permanent Residency. The federal government must increase its capacity and infrastructure to enforce the laws and provide efficient means for foreign nationals to obtain legal authorization for temporary visas or legal permanent residency.
- 7. Improve Process for Temporary Workers, and to Become Legal Resident or Citizen. The federal government must provide an appropriate, legal means of immigration, as is determined to be necessary and effective for the United States, for foreign nationals that want to work here temporarily, become legal permanent residents, or gain citizenship.
- 8. Provide Path to Legal Status and Citizenship With Strict Conditions. The federal government should establish a process whereby undocumented immigrants currently living in the United States may earn legalized status through payment of appropriate fees and back taxes, background

checks, absence of criminal or gang activity, consistent work history, and meeting English and civics requirements; and that the immigrants who have earned such legal status should also be able to apply for citizenship through additional processes, as appropriate and practical, as long as they do not move ahead of applicants with proper documentation waiting to adjust their status or those waiting on lists in their home countries.

9. <u>Assist Local Governments Affected by New Immigrants</u>. The federal government should provide local governments with financial and technical assistance to alleviate the

local impact of new immigrants, including the costs of providing social services, health care, education, language services, and civic integration.

The final Administrative Services Policy Committee meeting for the current year will be held on September 18, 2013 at the League Annual Conference in Sacramento only if a resolution falling under the Committee's jurisdiction is submitted. The next League Board of Directors meeting will be held in San Diego on July 11-12, 2013.


